

The August 27, 1951 meeting of the Town Assembly was held in the Guild Hall, Arden Delaware with Trustee Ware presiding.

After a quorum was declared present the minutes of the July 23, 1951 were read and approved.

The financial report of the Trustees for the period July 23 to August 23 was read and approved. Trustee Ware reported that the State Board of Health had tested the drinking water and reported it pure. The proposed raise in water rate by the Suburban Water Company will be heard by Public Service Commission on September 30, 1951.

Civic Committee - Swamp has been filled and leveled. The Memorial Garden has been completed and resceded. Area back of the Guild Hall has been cleared out and leveled. The town was sprayed with DDT. The memo for the pool was \$987.75 but all the expenses have not been computed as yet. Mrs. Worrell reported that the Civic Committee has had difficulty in getting work done this summer.

Assessing - They were sorry to report the death of Harry Pressman who had served the community long and faithfully.

Budget Committee. A motion to dispense with the reading of the budget passed because everyone had a copy to study.

The budget as presented by the Budget Committee passed and it will be ~~again~~ presented to the residents for approval or disapproval by referendum.

Registration Committee - no report
Community Planning Committee - Mrs. Edith Ware has been elected to serve as chairman this

year. They are planning to study ^{ways} of taking care of the forests. Report accepted.

Advisory Committee: One of the problems that had been discussed is the problem faced by the Registration Committee to know who are residents because of the many changes in Aude. The Committee feels that new residents should be responsible for getting placed on the voting list. It was suggested that this matter be referred to the By-Laws Committee and that they report on their suggestions at the October meeting. Report of the Advisory Committee accepted.

Auditing Committee reported that they had examined the trustee books and found them to be in order. Report of committee accepted.

Safety Committee report progress.

School Trustee - Harold Mump reported that a third teacher has been hired.

The Chairman of the Advisory Committee was to be selected but it was impossible to elect one from the floor. Therefore motion was made and passed that a nominating committee be appointed to bring a slate to the October meeting.
