

The regular meeting of the Town Assembly was held on March 25, 1963 with H. D. Ware presiding.

A letter from Brooks Houstem and Johnson to the Assembly urging all residents to clean up their properties and help keep communal property free of litter was read.

A letter from the Community Planning Committee was circulated requesting residents to keep corners trimmed to insure a clear view for cars, keep property cleaned up, keep dogs tied and asked that residents help keep a den a garden spot.

The financial report of the Trustees was read and a copy is on file.

H. D. Ware reported for the Trustees that they have been in touch with the attorney for the Water Company and detail of a franchise must be worked out. Work will be started soon.

The Town Council ~~attorneys~~ is trying to work out best way to provide sewerage disposal to a few properties that are too long to be serviced by present lines. Some may need pumps but a new spur is being considered. Looking Frankelstein to take care of houses in that area that cannot use gravity flow to present lines. The report on motion was accepted.

Cur Committee report by Albee Williams. The Committee has made several extensive tours of the community to outline work to be done. There are several lots in such disorder that the committee referred the matter to the Trustees for legal action. The financial report of the Cur Committee was read. The report of the committee on motion was accepted.  
No report for Assessors & Budget Committee.

Community Planning Committee. The committee has sent an appeal to all residents to clean up grounds, take care of garbage properly, and to take care of corners to help fire visitors on roads. On motion the report was accepted.

Registration Committee reported results of November referendum. All items on the Budget passed. There were 257 voted out of total of 360 or 70.2%. Assessors elected were: Henry Aughey, Shaul Hodston, Morris Rosen, Carl Van Orckle, Bernard Brochman, Francis Furman, William Press.

Advisory Committee. all items have been reported by other members.

No report for Credity Sewer + Water, Safety, or By Law Committee.

New Business. Donald Stephens questioned the way the land rent was made out. It was explained that the assessment was for total figure of 11.71 but part of the figure was for payment of sewer forty and that amount was shown at bottom of bill. It is not an extra assessment.

A motion was made and passed to have the secretary cast a ballot electing May Morley secretary of the Town Assembly unanimously.
