Community Planning – Mark Wood will present a **Motion** to create an Education and Governance subcommittee. He will send wording of motion to town secretary. Community Planning Report and the motion both will be moved up to be presented following Assessors Report. Mark will write up why they are presenting a motion and allow time for Q & A prior to presenting it for a vote. (time limit defined beforehand). Brooke requests that presentation be all laid out, so we do not have to go over it.

Forest- Carol Larson

Ordinance #4 addresses use of forests and commons (no dumping, no fires, etc.). Does ordinance #4 needs to be modified to include trespassing?

Jeff - If leaseholder encroaches, then Village will send a letter to address it. How is this enforced? If after receiving a notice by Village they do not comply, the Village takes legal action. If the Village boundaries are encroached, they have legal right to enforce it.

Elizabeth Varley says there are forms of trespassing that people do not view as trespassing. For instance, running a pipe from leasehold into woods. It might be good to add a little language in letter that provides examples (pipes, mowing, etc.).

Danny suggests checking with Bellefonte, neighboring communities, NCC & John Cartier to see what they do to their parks.

Playground – Larry Walker standing in for Daryl Holcomb (Absent)

Playground Committee will hold 2 public meeting in March:

March 12th opening meeting to receive input from the community as to the type and the style of the playground equipment to install.

March 19th open meeting is to present their suggestions based on public comments, interests and concerns.

Motion: If the town shows interest, the committee would present a plan for upgrading & adding new playground equipment, including budget amounts for TA's approval and request approval to craft an application for \$33,000 grant. No town money involved. (Jeff - it's an application for a grant and the work to be done before June. The money needs to be spent in the state fiscal year ending June 30. *Note - The information about spending the money by fiscal year was not known at the March 2 advisory. At that meeting we thought that the money did need to be spent by the end of June.). Jeff points out that Rep. Ray Siegfried had money set aside in the state budget for this playground upgrade. Money has already been earmarked. Now it's a matter of whether it can be done and if there is an interest in the upgrade and how best to use that money.

Safety - Brooke

Intersection task force group has been working with Rep. Ray Siegfried and Deldot to have a new strategy for the intersection at Harvey Rd and Marsh Rd. They have arrived at a potential fix for it that meets the challenges that Arden presented. There is a website that goes active today, March 2. This website is a way that people can communicate with Deldot directly about this project. Brooke will email all committee chairs and officers with the website address. Brooke will also post to social media. This is an eighteen-month plan.

5) New Advisory Committee Business

5a) Advisory Retreat – Danny will set up a retreat sometime in early June to be held on a Saturday. Exact date to be determined. Brooke would like to see listed on the agenda a long-range plan as a whole for the community. Specifically, she would like to see ADA compliance addressed for the houses located in the area better known as the “doughnut hole” (houses located in Ardens but are leaseholds in NCC, not Arden). Another topic to address would be Commercial Property. Mark Wood says Community Planning is addressing many long-term projects that is a work in progress. Reminds it all takes time.

5b) Deborah Ricard - Ad hoc committee is having their yearly Meet and Greet the candidates on Saturday, March 14 at the BWVC at 1 p.m.

6) Guests Comments and Questions

Marianne Cinaglia wants to increase voter turnout for Officer and Committee elections.

Background

She cited two bills by the state to address increase in voter turnout:

1) The state created a law that gives early voting (10 days early) for the right of Delaware voters for state matters. This bill passed.

2) Another bill is currently being presented to change absentee voting ballots forms, in which no excuse is required. (Municipal law reads you can use absentee voting for any reason that's in the municipal charter. She believes it would be a charter change because it says you vote for committee members not the Chairman of the Town Assembly).

She also noted that Arden tried early voting back in 2002 resulting in 34 early votes. Elizabeth Varley explained that year demand for early voting was because of the controversial election of the Village Chair position between Bill Press, the incumbent and Steven Threefoot which produced high voter turnout. Barbara Macklem - The next year had only 3 early voters. Several years opened early but each time early voters dwindled precipitously. Since then, Registration has a fully established absentee ballot system. It was not in existence in 2002. There has been a shift in the process.

Absentee Ballot Form

Mariann suggest that the Arden's Absentee ballot form be changed from its present limited criteria to be the same as the state's ballots that have no excuse necessary to obtain Absentee ballot.

Barbara Macklem says they have never turned anyone away who requested an absentee ballot and ballots are not restrictive. Barbara reviewed the 4 options listed on the Arden's Absentee Ballot. They are as follows:

- My business or occupation prevents me from voting at the Town Meeting. (“Occupation” may include care of a family member.)
- I will be out of town on election day. (This includes military service, college, or vacation as examples.)
- The tenets or teachings of my religion prevent participation in the election.
- I have a physical disability – either temporary or permanent – which prevents me from voting at the Town Meeting.

Deborah Ricard suggest adding Other as a choice on the form.

Jeff - Concerned about eliminating reasons. Show up and be informed.

Good topic for retreat agenda.

Barbara will take the suggestions to change the absentee ballot back to the Registration Committee to discussed further.

Registration Committee Meetings Posting Notices.

Although Registration Committee is in compliance with FOIA requirement of posting their meeting notices on bulletin board located at the BWVC at least 7 days prior to meeting, Marianne would like Registration to post several notices of their meetings such as to list in the Arden Page (It is believed that the Arden Page is not the “Newspaper of Record”. Informative but no authority) and post to the Village website. The Registration Committee agrees they will post their meeting notice on the Village website as well as continue to post to the bulletin board.

A motion was presented by Danny Schweers, Advisory Chairman, to move Community Planning and Playground Committee reports and motions forward on the agenda to be the first two committee reports. Motion: voice vote Approved. 1 No, 2 abstentions.
