

**Arden Forest Committee Meeting**  
**Wednesday, November 11, 2020, 7:00 PM**

**Via Zoom: In attendance: Carol Larson, Jen Borders, Jill Althouse-Wood Bev Clendening.**  
**Absent: Dave Jones. Meeting called to order 7:07 PM**

1. **Administrative:** We approved October minutes.
  - Jen looked at the Fire Permit to arden.delaware.gov. We have some changes. We need a signature line. And we need to change the out-of-order pages. Corrections need to be made, before Cecelia can make it interactive.
  - Please update volunteer hours for the last month.
2. **Finance:** No new report. No changes. Ron's Tree service has been paid \$3000. We need to check on that. Ron still has another tree to bill us for Mill Race Road. Carol talked to Red Tail about amending their contract. has a receipt to submit for ash treatments. Jill submitted receipt for the Arden Patch. Carol bought plants and mulch for Sunset Farms hoping to get reimbursed from Schroeder.
3. **Current Grants/Projects**
  - Sherwood Restoration Project: Carol is still graphing the data to do. Foresite will be doing a final report.
  - 2409 Woodland: Some Mile-a-minute we have to watch. not a priority.
  - End of Hillside/Sherwood Forest planting circles: Jill needs to take photos.
  - Surface Water Management: Nothing new
- 4 **Boundaries/Encroachment**
  - Sunset Farms: Sod removed, brought in plastic barrier, mulched, brought in plants to be planted on Friday/Sat. Lots of invasives to deal with there.
  - Christine and Don Montgomery at 2033 Marsh Road. They have a pipe draining into woods. Carol needs to talk to them.
5. **Drainage/Erosion**
  - Jill will talk to Dave Nordheimer to continue to monitor erosion at Broadbent. Jill will ask him to take a photo from a stake point. Carol checked out the bamboo in the gully. We need to get rid of it next on our list.
  - We will check Sunset Farms for signs of erosion. Carol will talk to DNREC Debris Pit about the water direction.
6. **Invasive Species Control**
  - On hold: Jill talked to Larry Strange about drone video and 360 photography to map the ivy. He is talking about winter.
  - Bev looked into iMap invasives. Delaware is now part of the cooperative. Bev signed up and is working to use the program.
  - SLF report: Traps are still catching. We will be going into scraping egg case phase soon. Maples are catching most right now.
  - Knotweed is looking better. Carol found a new patch at Bryan leasehold that she wants to treat. Carol is confident we can knock it out next year. Some at the Aumack leasehold.
  - Discussed deer population control. Need to prepare Arden for possibility of population control by State Forester so we can preserve our understory.
7. **Paths/Maintenance**
  - Sherwood Bridge project on hold due to budget constraints.

--We need to retrieve a bridge from where it washed away downstream. We need 4-6 people. Checked weight when weeding at 2409 Woodland.

-- trunk still across the path near Bev's house has been removed.

8. **Removals/Monitoring/Inventory of Trees**

--Oak behind Dela Bryan that is uprooting. Mixed opinions about the tree. We need a second opinion. It would be about \$1800 for removal. We will watch it.

9. **Community Involvement and Communications**

--Happy Hour planting party scheduled for Sunset Farms for November 13 at 2:30 PM. Carol will get cider. Jill will get wine.

--Buzz Ware will be certified as a habitat. Responsibility for exterior of Buzz is Civic responsibility. Carol will talk to Civic about certifying.

--We are well under way process of certification for the Ardens for Community Wildlife Habitat. The Gardeners Gild is going to be a part and possibly pay for the certification.

--New LEAF winter edition. Jen is writing article on birds. Carol write about Arden Mill Race Preserve.

- a. *a community-wide environmental stewardship plan including forests, greens, leaseholds, and storm water management with input from Ardentown and Ardencroft.*
