#### *The Stile cleanup*

Invasive ivy, Multiflora rose, dead debris and fallen branches need to be cleared from the area. This job will be turned over to Larry Walker. Rod recommended 'Round up'.

#### *Sign renewal*

Seth Baker has no time to accomplish this before the fall. The committee will look at other options.

#### *Sherwood Green trees*

Several were removed by the BWVC in preparation for the installation of solar panels. BWVC paid for the removal and will replace the tree on the Highway by the trash containers. The committee will suggest at town meeting that the Copper Beech donated by Rodney could be planted there. The town may prefer a native White Oak

#### *Field Theater*

Repairs and screening fence replacement were approved and completed for the Shakespeare Gild production of The Tempest. The Gild will purchase and install 2 additional lighting fixtures at their expense and arrange a defective transformer under warranty to be replaced.

Rodney will permanently mark the survey stakes.

#### *Tree on a Green telephone wire*

This was removed by Gabe Colgan after Verizon refused the work. Larry Walker will pick up the debris.

#### *R.O.W. complaint*

The committee thanked Rod for addressing this issue @ 1901 Millers Rd to the new leaseholder.

#### *Electronic Recycle*

Approx. 100 items were collected for recycle on the Earth Day Clean up.
